Committeeman Owens reported - Chairperson of Streets and Roads, Fire, Ambulance and recreation The road crew is working be patient lots of pot holes to fix and other issues this time of year.

Requisition form was approved to be used for items \$1500.00 or more.

Mr. Elwell asked about the dog shelter. Mayor Sperry explained the increase in fees and we are looking for alternatives.

Mr. Counsellor is working on his year end report and he will be applying for more grants this year.

Mr. Winkels asked why the ice dams weren't included and Deputy Mayor Hannagan said it was just an oversight we will get them done.
